### **Resident Research Grant** **Submission deadline: 1 December**

In keeping with the objectives of the European College of Veterinary Surgeons, whereby ECVS encourages Diplomates and prospective members to pursue original investigations and contribute to the veterinary literature, ECVS has established a research grant programme. Surgically related clinical research proposals will be considered for funding.

Resident Research Grants shall be available to trainees registered with ECVS and enrolled in an ECVS-approved European Surgery Residency Programme or Alternate Training Programme. As these grants are expected to support studies contributing to the research and publication components of the training programme, it is expected that eligible trainees will substantially participate in developing and writing the proposal and that results of such funded studies will be published within one year after completion of the study. Consequently, trainees are encouraged to apply during the first half of their program training time as the projects should be completed at the end of the training period. If applicable, manuscripts of ECVS-funded studies should be submitted to Veterinary Surgery for publication.

At the discretion of the Board of Regents and the Research Grant Committee, the amount to be granted will be determined annually. Currently, two grants up to € 7500 (seven thousand five hundred euros) will be awarded annually, one for a large animal project with the second for a small animal one. Proof of full funding for a project only partially fundable with ECVS support must be received together with the application. Credit to the ECVS Resident Research Grant shall be given in resulting publications, regardless whether full or partial funding has been obtained.

*Application forms* are available from the ECVS website ([www.ecvs.org](http://www.ecvs.org)).

*Application deadline:* Completed grant applications must be received at the ECVS Office by 1<sup>st</sup> December. The Research Grant Committee will evaluate proposals and propose potential awardees to the Board of Regents at the February Board Meeting. Shortly thereafter, grants will be distributed. A formal announcement of successful applicants will be made at the Annual Scientific Meeting in July after receipt of the grant money. This should allow commencement of funded studies without undue delay.

*Funding considerations.* Funds may be used only for direct expenses of the project. Travel, consultative fees, publication fees, personnel costs, and institutional overheads will not be funded by the grant. If the proposed length of the study is greater than one year, the total award may be allocated in installments. A time limit of two years is suggested for

completion of the research, although exceptions may be granted by the Board of Regents.

*Compliance with Human Care and Use of Animals:* Each proposal must include written and supervisor-signed proof of compliance with the requirements for "Humane Care and Use of Animals" as outlined in the ECVS Training Guidelines. This would generally be in the form of a statement of Ethical Approval for the project from the Ethical Review Board of the applicant's institution. Only submissions which fulfill this requirement will be forwarded to the Research Committee. The Research Committee will not see this statement in the initial evaluation process as it would give away the source of the study.

*Guidelines for submission of proposal:*

1. Proposals (one hardcopy and one electronic copy, either email or CD) should be sent to the ECVS Office by 1<sup>st</sup> December. Receipt of each proposal will be acknowledged.
2. Proposals will be forwarded to the ECVS Research Grant Committee by the ECVS Office. The Research Grant Committee consists of three members of the college.
3. Proposals are scored applying a 100-point system: Overall quality of proposal: 40 pts, potential impact: 20 pts, originality: 10 pts, feasibility to carry out the investigation at the proposed site: 20 pts, budget appropriateness: 10 pts. The first three and the last category are scored with the Research Grant Committee blinded to the applicant and institution. Thus, the name of the applicant and the institution should not appear in the body of the proposal (Research Proposal). Once the proposals are scored for these criteria, the members of the Research Grant Committee will be provided with the additional information, upon which the score for the fourth category is then based. Each ECVS Research Grant Committee member will grade each proposal. Proposals are then ranked and will be submitted to the ECVS Board of Regents in rank order. During the February meeting, the Board of Regents will decide which proposal(s) will be funded. All applicants will be notified of the Board's decision shortly after its meeting.
4. When proposals are successful, the applicant's institution or a non-institutional individual Diplomate is to send ECVS an invoice for the granted amount and payment will be made.
5. Average scores per category and total score will be sent to all unsuccessful candidates.
6. *Reporting:* A yearly report (submitted electronically) on the progress and results of the study must be submitted to the ECVS Research Grant Committee Chair via the ECVS Office Zurich by January 15, each year, until the project is completed. Publication(s) from the work should be submitted electronically and one hard copy sent to the ECVS Office and publish pertinent information in the ECVS Newsletter. Failure to comply with the requirements above may result in the supervising Diplomate being denied the right to act as such on further proposals.
